- 5.1 The transcripts of the previous meeting were reviewed.
- 5.2 The online Course Registration Form was presented by Mr. Jobin Jose. The following suggestions were put forward to improve the same:
 - Provision for students to register only for Odd semester courses during an Odd semester, and Even semester courses during an Even semester is to be incorporated.
 (i.e. S5 students can register only for S1 & S3 courses, S6 students can register only for S2 & S4 courses etc)
 - (2) A mechanism to check that the total number of credits of the courses for which a student registers does not exceed 28 is to be incorporated
 - (3) The printout of the form should contain the following: "Total number of credits for which registered:", and its semester-wise breakup "Total number of credits earned to date:...", and its semester-wise breakup
 - (4) The clauses about 80% attendance, medical leave and improvement test should come above the 'Declaration'
 - (5) Provision to enter Aadhaar number should be added
 - (6) In the section where details of residence is mentioned, if the student is staying in own house, but away from parents, provision should be made to find out if there is anyone else staying with him/her. If so, the student's relation with the other resident, the latter's name, and phone number should be asked for
 - (7) There should be a provision for 'Parent's Signature' on the printout

It was decided that the Course Registration Form would be uploaded on August 19, 2017, and that students will be directed to submit the printout with the supporting documents on or before September 18, 2017. The IAC department representatives should ensure that

students of Semester III and V complete the KTU Course Registration process before August 18, 2017.
