This has reference to your application I.D. No. 2434-05/06/2017 seeking accreditation by National Board of Accreditation in Tier-II format to UG Engineering program offered by **Rajagiri School of Engineering & Technology, Rajagiri Valley P.O., Kakkanad, Ernakulam District, Kochi-682039, Kerala.**

2. An Expert Team conducted on-site evaluation of the program from 09<sup>th</sup> to 10<sup>th</sup> February, 2019. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The competent authority in NBA has approved the following accreditation status to the program as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for three years. **Rajagiri School of Engineering & Technology, Rajagiri Valley P.O., Kakkanad, Ernakulam District, Kochi-682039, Kerala** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Rajagiri School of Engineering & Technology, Rajagiri Valley P.O., Kakkanad, Ernakulam District, Kochi-682039, Kerala** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
